Jail Administrator, Rebeca McKibben, gave the Jail Count, as follows:

Rebeca also stated, she has 1 inmate waiting to be picked up for TDCJ. She stated she had the Jail Fire Inspection done, she ended up receiving a yellow tag, due to there not being a cage on the red fire sensor. She is getting that fixed, she will then receive her White Flag, and she will pass the inspection. Chief Deputy Derek Hester stated the Sheriff's office helped 7 families this Christmas with gifts that were donated during the Toy Drive. He also stated there will be extra forces out on New Year's Eve to help protect the County.
