Lynn County Commissioner's met in first regular session on Monday, February 11, 2019 at 9:30 a.m. in the County Judge's office located at 1524 Harper Street. Commissioner's Hawthorne, Blair and Durham were present. County Judge Braddock presided. Commissioner Woodley was absent.

Agenda #2: Discuss and act upon Resolution of The Lynn County Appraisal District Board of Directors

- (c) One (1) member of the Lynn County Appraisal District Board of Directors to be appointed jointly by the City of O'Donnell and O'Donnell Independent School District;
- (d) One (1) member of the Lynn County Appraisal District Board of Directors to be appointed by the Tahoka Independent School District;
- (e) One (1) member of the Lynn County Appraisal District Board of Directors to be appointed jointly by the City of Wilson and Wilson Independent School District.
