Lynn County Commissioner's met in second regular session on Monday, February 23, 2015 at 9:00 a.m. in the basement Courtroom. Commissioner's Wied, Blair, Hawthorne and Durham were present with County Judge Braddock presiding.

Agenda Item # 2: Discuss and act upon the revision of the Lynn County Employee Handbook section 8.01.02 regarding Lynn County Employee Health Insurance benefits to reflect that only eligible Lynn County employees are to be covered by county health insurance at no cost to the employee and that any eligible dependents may be covered at the expense of the employee should the employee elect to do so.

Commissioner Larry Durham moved to approve a revision of the Employee Handbook section 8.01.02. The revision states that only eligible Lynn County employees are to be covered by county health insurance at no cost to the employee and that any eligible dependents may be covered at the expense of the employee should the employee elect to do so. Commissioner Blair seconded the motion with Commissioner's Wied and Hawthorne voting in favor.

Agenda Item # Addition to Agenda #1. Discuss and act upon allowing a full time eligible employee that wishes to decline the health insurance provided by the county because the said eligible employee is currently paying for other health insurance available to the employee, to receive reimbursement for the actual cost of the health insurance premium paid by the eligible employee up to the amount that would otherwise be paid by Lynn County for the employee's health insurance. Commissioner Don Blair moved to act upon a Resolution for the Extension of Chapter 313 of the Texas Tax Code that supports the increased tax benefits to the local school district and continuation of local decision-making power to approve projects and urge the state Legislature to show its support of rural Texas communities by only passing bills that are stated in the Resolution. Commissioner Wied seconded the motion with Commissioner's Hawthorne and Durham voting in favor.

Agenda Item #4: Consider and act upon accepting Inter-local Agreement with Garza County for CVA

Commissioner Keith Wied moved to accept an Inter-local Agreement with Garza County for the Crime Victim's Advocate and Commissioner Durham seconded the motion with Commissioner's Hawthorne and Blair voting in favor.

Commissioner John Hawthorne moved to seek bids for courthouse repairs for masonry work. Commissioner Durham seconded the motion with Commissioner's Wied and Blair voting in favor.

Commissioner Don Blair moved that Lynn County apply for unclaimed capital credits with the Texas Comptroller Office and Commissioner Hawthorne seconded the motion. Commissioner's Wied and Durham voted in favor.

Commissioner Larry Durham moved to accept the Annual Certification of Compliance phase II from Stevens Ranch Wind Energy, LLC. Commissioner Wied seconded the motion with Commissioner's Hawthorne and Blair voting in favor. Phase II is expected to be commercial in Q2 2015.
