If you fail to respond by the appearance date shown on the citation, you will be charged with a Violate Promise to Appear (\$245.00), a warrant will be issued for your arrest, your Driver's License will be suspended, and you will be submitted to a collection agency.

If you are an Out-of-State Violator and you fail to respond to the citation issued, procedures will begin in notifying the licensing authority in your state to **suspend your Driver's License, and you will be submitted to collections.**

I hereby enter my plea of (circle one) **GUILTY** or **NOLO CONTENDRE** to the offense, and request permission to take a Defensive Driving Course.

In order to take a Driver Safety Course, the court must be furnished with the following Post Marked by the Appearance Date on the citation -If any part of the below list is omitted, your request for Driver Safety Course will be denied:

1. A clear copy of YOUR VALID TX DL.
2. A copy of **Proof of Liability Insurance**.
3. A money order or cashier's check (**NO PERSONAL CHECKS**) in the amount of **\$111.15**.
4. **Sign the Sworn Statement** below before a Notary Public that all facts above are true and correct.
It is a felony offence to make a false statement under oath.

YOU CANNOT HAVE:

1. Been driving 25 m.p.h. or over the posted speed limit
2. Taken a Driver Safety Course in the last 12 months, or currently taking a course for another violation.
3. Driving a Commercial Vehicle, hold a CDL's or Out of State Driver's License.

YOU WILL HAVE 90 DAYS FROM THE APPEARANCE TO COMPLETE AND MAIL IN:

1. The court copy of Driving Safety Course Certificate—The Court Copy.
2. Your Driving Record. You can request your Driving Record online at www.texasonline.com - request Type 3A.
3. **FAILURE TO TURN IN DRIVING RECORD AND/OR DRIVER SAFETY COURSE CERTIFICATE WILL RESULT IN DENIAL OF DSC CREDIT.**

I understand if I fail to comply and meet court dates, I will pay the fine or a warrant will be issued for my arrest.
