# 6. Discuss and act upon Terralogic Contract for Scanning and Destruction of Criminal Files in the County Clerk's Office

Karen Rendon, County Clerk spoke about Terralogic coming down to pick up all the old criminal files that are being stored at City Hall in Tahoka, and scanning them in to make them electronic copies and then after the electronic copies are made and input into the case management system in Karen's office, the

hard copy of the files will be destroyed. It is going to cost Karen \$27,106.76. She will pay for this out of her Records Management Account. That account is only used for projects like this. Commissioner Gass made the motion with Commissioner Durham seconding that motion to accept the \$27,106,76 bid to scan and destroy the Criminal Case Files. All voted in favor, motion carried.

#### 11. Discuss and Act upon Tower repairs quote(s)

Judge Braddock started off the discussion saying Canadian River called last week stating the lights were out on the tower. Canadian River and another company and us, Lynn County are partnered together. Canadian River Authority came out and cleaned up around the bottom of the tower but when they contacted us, Judge Braddock contacted Western Towers out of San Angelo and told them what the situation was and sent them all the specs on it. Western Towers sent back a quote for \$12,526 to replace those lights. Judge then stated they were going to replace those lights rather than repair the lights due to the lights being LED lights. Judge Braddock then sent the quote to the Sheriff's Office. Sheriff then stated she had contacted South Plains Communications and asked if they would be interested in getting us a quote for this repair. She has not yet received that quote yet. Commissioner Gass made the motion with Commissioner Woodley seconding that motion to table this discussion until more information was presented. All voted in favor, motion carried.
