Commissioner's Woodley, Hawthorne, Gass, and Durham were present, and the following member(s) absent: Judge Braddock, constituting a quorum of the Court present, at which time the following business, among other proceedings, was had:

Lynn County Tax-Assessor Collector, Kathy Grant started the meeting with the invocation and Commissioner/Judge Pro-Tem John Hawthorne led the pledge of allegiance to the United States and Texas flags.

## 2. Public Comments pertaining to agenda items

Commissioner Hawthorne gave the public an opportunity to discuss anything relating to agenda items. No one from the public addressed the court.

## 3. Kaci Scott to give update/report on Extension Office

Sierra Stephens and Kaci Scott both presented what they have been doing within the Extension Office with 4-H.

#### 4. Discuss and act upon 207K Resolution

Commissioner Hawthorne stated this resolution is for the change in hours of Law Enforcement Officers and Detention Officers from a 14 day pay period at 84 hours to a 14 day pay period at 86 hours. ## 10. Discuss and act upon Dispatch Service Interlocal Agreement – City of O'Donnell

Sheriff Mason stated the City of O'Donnell pay their portion of \$5,000 in separate equal payments within the year. Commissioner Hawthorne made the motion with Commissioner Gass seconding the motion to accept the Dispatch Service Interlocal Agreement with City of O'Donnell. All voted in favor, motion carried.

## 11. Discuss and act upon Dispatch Service Interlocal Agreement - City of Tahoka

Sheriff Mason stated the City of Tahoka pays \$52,396. Commissioner Durham made the motion with Commissioner Gass seconding the motion to accept the Dispatch Service Interlocal Agreement with City of Tahoka. All voted in favor, motion carried.

## 12. Discuss and act upon Accepting donation from Lubbock Co. SO vehicle transfer by requisition to Lynn County SO for New Home ISD PD

Sheriff Mason stated Jacob Garza had gotten in touch with her, asking if LCSO would be willing do this for New Home ISD PD. Lubbock SO and Lubbock PD have a surplus of older vehicles. The ones that they do not auction off, they will donate to smaller counties. They can only donate to a county. Commissioner Woodley made the motion with Commissioner Durham seconding that motion to accept the donation from Lubbock Co SO for New Home ISD PD. All voted in favor, motion carried.

# 13. Discuss and act upon donation from Lynn Co SO to New Home ISD PD – older radio system and emergency lighting to equip vehicle transferred to New Home ISD PD

Sheriff Mason stated they have older model Motorola's that they haven't been able to auction off, along with some emergency lighting. Commissioner Gass made the motion with Commissioner Woodley seconding the motion to donate the older radio system and emergency lighting to New Home ISD PD. All voted in favor, motion carried.

## 14. Approve and pay claims and payroll against the County
