10. Discuss and act upon UMC Physicians continued contract re: new medical records system, EPIC

Chris Henssley, Chief Deputy stated UMC Physicians upgraded to a new medical records system and they need an updated contract for the services they provide to Lynn County. Commissioner Gass made the motion with Commissioner Hawthorne seconding the motion to accept the contract with UMC Physicians. All voted in favor, motion carried.

11. Discuss and act upon Lynn County entering into a SPAG EGrant for Sheriff's Office Deputies. The Resolution to title – Active Attack Response Equipment Grant Program – Ballistic Shields

Chris Henssley, Chief Deputy stated TCOLE has now that every school campus has to have a ballistic shield. SPAG is offering these grants, but the problem is the Homeland Security is all tied up. Chris also stated the SPAG may not receive the funds for these grants, wants to be sure that if they end up receive the funds, that we, Lynn County, are on the list to receive them for their patrol deputies. Commissioner Durham made the motion with Commissioner Gass seconding that motion to enter into a SPAG EGrant for the Ballistic Shields. All voted in favor, motion carried.

Addition #1. Discuss and act upon Resolution for Criminal Justice Program, Juvenile Justice & Truancy Prevention Grant Program, FY 2026/2027

Bryant Sears, Chief Juvenile Probation Officer stated this is a grant they apply for every year. This grant is for counseling funds. We receive \$81.25 per each counseling session, and \$650 each psychological evaluation. This is a reimbursement grant, that is not just for our county but for our region. The grant is for about \$78,000.00. Commissioner Hawthorne made the motion with Commissioner Gass seconding the motion to approve the Resolution for Criminal Justice Program, Juvenile Justice & Truancy Prevention Grant Program. All voted in favor, motion carried.
