County Treasurer, Amy Schuknecht spoke about the changes to the longevity. She stated due to the fact that some long-time employees retired this year, the payout for longevity has gone down. She also stated that the changes will only affect the employee's that have been here 10 years or less. Commissioner Blair made the motion with Commissioner Hawthorne seconding the motion to accept the longevity changes. All voted in favor, motion carried.

### 5. Discuss and act upon TAC HEBP Benefits for 2025

County Treasurer, Amy Schuknecht, spoke about the TAC HEBP Benefits. She stated TAC lowered the increase of the policy so that we could just stay the same. Medical is going up \$37.16, Dental is going up \$0.78, per month per employee. It is about \$456/year per person, with over 50 employees, it is going to be about \$22,800.00 a year. Commissioner Hawthorne made the motion with Commissioner Durham seconding the motion to accept the TAC HEBP Benefits for 2025. All voted in favor, motion carried.
