- Change the contribution of retirement from 5% to 7%

- Update the cafeteria plan
- Add to the vacation leave: if employee leaves without notice, or is terminated with-cause they are not to be paid out the 80 hours of vacation leave.
- If an employee is Licensed to carry, there has to be a form signed with the County Judge and supervisor.
- FMLA policy

Commissioner Woodley made the motion with Commissioner Durham seconding the motion to make the changes on the Policy and Procedure Manual. All voted in favor, motion carried.
