Commissioner's Woodley, Hawthorne, Gass, and Judge Braddock were present, and the following member(s) absent: Commissioner Durham, constituting a quorum of the Court present, at which time the following business, among other proceedings, was held:

County Commissioner Hawthorne started the meeting with the invocation and Judge Braddock led the pledge of allegiance to the United States and Texas flags.

2. Public Comments pertaining to agenda items

Judge Braddock gave the public an opportunity to discuss anything relating to agenda items. No one from the public addressed the court.

3. Representative from Tienert Construction here to discuss roads

Representative from Tienert Construction did not show up for a discussion.

4. Discuss and act upon purchase of Honor Guard Uniforms for LCHD EMS

Commissioner Hawthorne made the motion with Commissioner Gass seconding the motion to accept the purchase of 4 (four) Honor Guard Uniforms for LCHS EMS. All voted in favor, motion carried.

5. Consider and take action of the Indigent Defense Contract for District Court FY 2026

Judge Reed Filley stated Artie Aguilar's fees went up but the Investigators fees stayed the same. Commissioner Woodley made the motion with Commissioner Gass seconding that motion to accept the Indigent Defense Contract for District Court FY 2026. All voted in favor, motion carried.

6. Discuss and act upon Contract with LGS Software for JP Pct 1.

Christie Olivan stated she had received bids for a new software company for JP Pcts 1&4 and LGS was the best bid. Commissioner Woodley made the motion with Commissioner Hawthorne seconding that motion to accept the bid from LGS for JP Pct. 1 for \$473 monthly. All voted in favor, motion carried.
