Lynn County Commissioner's met in second regular session on Monday, May 29, 2018 at 9:00 a.m. in the County Judge's Building located at 1524 Harper Street. Commissioner's Woodley, Hawthorne, Blair and Durham were present. County Judge Braddock presided.

Agenda # 2: Discuss and approve audit agreement with Bolinger , Segars, Gilbert & Moss L.L.P. for the year ended September 20, 2018

Commissioner Larry Durham moved to approve an audit agreement with Bolinger, Segars, Gilbert & Moss L.L.P. for the year ending September 20, 2018 in the amount of \$24,200. Commissioner Blair seconded the motion with Commissioner's Woodley and Hawthorne voting in favor.

Agenda #3: Pat Childress to address Commissioners Court pertaining to avian

Pat Childress addressed the court regarding Sandhill Cranes. Mr. Childress felt there would be no negative impact on the cranes from the wind turbines. Mr. Bruce Vaughn stated the same.
